Model Release

Agreement includes:

Contracted on _____ between the person signing below, hereinafter referred to as "the model" and Helbard Alkhassadeh, hereinafter referred to as the photographer.

In consideration of my engagement as a photographic model and for good and valuable consideration herein acknowledged as received, I hereby grant the photographer, his heirs, legal representatives and assigns, those for whom the photographer is acting, and those acting with his authority and permission, the absolute right and permission to copyright, in this name or otherwise, and use, re-use, publish, re-publish photographs of me or which I may be included, in whole or in part, or composite or distorted in character or form, without restrictions as to alterations, in conjunction with my own or a fictitious name, or reproduction thereof in color or otherwise mode through any and all media now or hereafter known, for illustration, promotion, art, or any other purpose whatsoever. I also consent to the use of any text used in conjunction therewith.

I hereby waive any right that I may have to inspect or approve the finished product or products and the text copy of other matter which may be used in conjunction therewith, or the use to which it may be applied. I hereby agree to release, discharge and agree to save harmless the photographer, his heirs, legal representatives and assigns, and all persons acting under his permission or authority, or those for whom he is acting, from any liability by virtue of blurring, distortion, alteration, optical illusion, electronic manipulation, or use in composite form, whether intentional or otherwise, that may occur or be produced in the taking or said photographs or in any subsequent processing thereof, including without limitation any claims for libel or invasion of privacy.

I, the model, release the Photographer, Helbard AlkhassAdeh, or others for whom he is acting, from any claims for remuneration associated with any form of damage, foreseen or unforeseen, associated with the proper commercial or artistic use of these images unless it can be shown that said reproduction was maliciously caused, produced and published for the sole purpose of subjecting the Model to conspicuous ridicule, scandal, reproach, scorn and indignity. I also understand that injuries, although uncommon can occur and that I willingly take these risks and release the Photographer, Helbard AlkhassAdeh, or others for whom he is acting, from any claims for remuneration associated with any form of injury, foreseen or unforeseen, during the taking of these photographs or the travel to and from the job site.

I acknowledge that this release was willingly signed. I hereby warrant that I am at least of the legal age of eighteen (18) and have the right to contract in my own name, that I have read the above authorization, release and agreement, prior to its execution and am fully familiar with the contents thereof. This release shall be binding up on me, my heirs, my legal representatives and assigns.
